IT IS HEREBY ORDERED that the motion is **granted**. Accordingly,

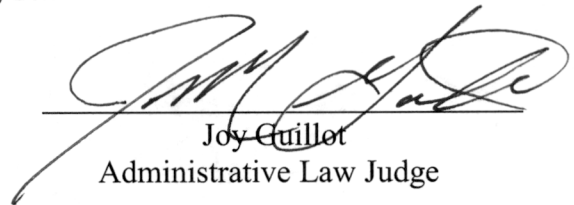
PLEASE TAKE NOTICE that the current procedural schedule is continued without date.
