Now before the Commission, through undersigned counsel, comes SOUTHWEST LOUISIANA ELECTRIC MEMBERSHIP CORPORATION ("SLEMCO"), who hereby files this Notice of Intent to Participate as an Interested Party and Inclusion on Service List in this proceeding pursuant to Rule 10 of the Louisiana Public Service Commission's ("LPSC's") Rules of Practice and Procedure, and states the following, to-wit:

1.

SLEMCO is a rural electric cooperative, domiciled in Lafayette Parish, Louisiana, organized and existing pursuant to the laws of the State of Louisiana.

2.

This proceeding was initiated when Entergy Louisiana, LLC ("ELL") filed its Application for Approval of Generation and Transmission Resources Proposed in Connection with Service to a Significant Customer Project in North Louisiana, including Proposed Rider, and Request for Timely Treatment.

Notice of this filing was published in the LPSC's Official Bulletin #1336, dated November 8, 2024, with the deadline for interventions to be filed on or before November 18, 2024. Therefore, SLEMCO's request is timely.

SLEMCO serves electricity to approximately 100,000 consumers in the southwest Louisiana parishes of Lafayette, St. Martin, Vermilion, Acadia, St. Landry, Jefferson Davis, Evangeline, Iberia, and Avoyelles; therefore the matters to be considered by the Commission in this docket could affect the operations and rates of SLEMCO.

5.

No other party to this proceeding is suited to adequately represent SLEMCO's interests. Accordingly, SLEMCO seeks to participate in this docket as an interested party.

Rule 10 of LPSC's Rules of Practice and Procedures provides that any party actually in interest may appear in any proceeding before LPSC.




