In re: Alleged violation of La. R.S. 45:161 through 180.1, by engaging in activities related to moving household goods prior to complying with the requirements of La. R.S. 45:164 (E) and General Order dated March 16, 2021 and for failure to comply with the requirements of General Order dated April 3, 2008 as amended.

AFFIDAVIT AND STIPULATION

I, <u>Benson Auger</u>, whose title or position is <u>Owned</u> of Benson Dupre Moving Services, LLC and who is authorized to enter into this agreement on behalf of Benson Dupre Moving Services, LLC, herein admits that Benson Dupre Moving Services LLC violated La. R.S. 45:161 through 180.1, by engaging in activities related to moving household goods prior to complying with the requirements of La. R.S. 45:164 (E) and General Order dated March 16, 2021 and for failure to comply with the requirements of General Order dated April 3, 2008 as amended. As a result, I agree to the imposition of a \$1,000.00 fine and a \$25.00 citation fee with \$500.00 of the fine being suspended contingent on the following conditions:

- Execute this Affidavit and Stipulation before a notary and return to LPSC Transportation Staff by May 1, 2024;
- Cease engaging in activities related to moving household goods including the advertising for such services until such time as a Common Carrier Certificate is issued to Benson Dupre Moving Services, LLC;

- 3. Benson Dupre Moving Services, LLC will file an application with the LPSC to obtain a certificate from the Commission authorizing the transportation of household goods on or before June 3, 2024.
- 4. Benson Dupre Moving Services, LLC agrees to pay the fine in three monthly payments as follows:
 - Executed Affidavit and Stipulation with first payment of \$193.00 due May 1, 2024;
 - Second payment of \$166.00 due June 3, 2024;
 - Final payment of \$166.00 due July 1, 2024; .
- 5. Failure to comply with any of the above requirements will result in the \$500.00 suspended portion of the fine becoming due immediately.
