CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY  
AS A COMMON CARRIER OF SPECIAL COMMODITIES  
OVER IRREGULAR ROUTES

NO. 7853

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO STATE LINE VACUUM SERVICES, LLC whose office or place of business is at HAYNESVILLE, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER of special commodities over irregular routes by motor, handling the following described commodities, in the territories described, and in accordance with the following limitations:

1. Restricted to the transportation of non-hazardous oilfield waste which originates north of a line drawn west to east across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles and West Feliciana Parishes.
2. When transporting non-hazardous oilfield waste by vacuum truck, State Line Vacuum Services will be restricted to the use of no more than twelve (12) company-owned/ leased vacuum trucks.
3. When transporting non-hazardous oilfield waste by roll-on/roll-off or dumps trucks, State Line Vacuum Services will be restricted to the use of no more than five (5) company owned/leased roll-on/roll-off or dumps trucks.
4. Restricted against the transportation of non-hazardous industrial solid waste and hazardous waste.
5. State Line Vacuum Services agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the date of issuance of the Common Carrier Certificate to State Line Vacuum Services in this proceeding.

(Issued pursuant to Order No. T-32843, dated October 29, 2013. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said STATE LINE VACUUM SERVICES, LLC shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
