As noted in the Joint Notice of Bidders and Technical Conference submitted into the record of this proceeding by ELL and the Commission Staff on December 13, 2024, the October 29, 2008, version of the MBM Order applies to the instant proceeding. Although the Commission adopted (on October 14, 2024) revisions to the MBM Order, the record of the proceedings at which the vote was held makes clear that the recently amended version of the MBM Order does not apply to the instant RFP, which was noticed in July 2024. *See*, Transcript of September 17, 2024 Business and Executive Meeting at pg. 54, lines 5-7 ("It is Staff's intention that the Commission's adoption of any of these rules would only apply prospectively after the issuance of an order in this proceeding.").
