Parties can participate in the status conference either in-person or telephonically. For telephonic participation the following is the dial-in information:

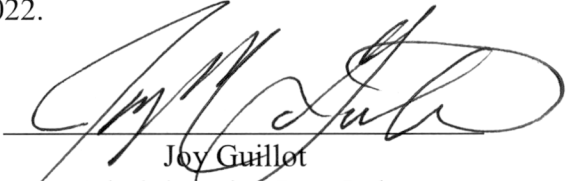
