July 13, 2020	Deadline for ELL Rebuttal Testimony.
August 10, 2020	Deadline to Issue Written Discovery on ELL regarding Rebuttal Testimony.
August 10, 2020	Deadline for Depositions.

PLEASE TAKE FURTHER NOTICE that deadlines for joint pre-trial statements and pre-hearing briefs, and a date for a hearing, will be set by the Tribunal after the end of suspension of legal deadlines.

PLEASE NOTE: Should the parties wish to proceed by stipulation, compliance with Rule 6 of the Commission’s Rules of Practice and Procedure is **required**. Accordingly, an uncontested stipulation hearing will not be scheduled or convened until the parties have complied with Rule 6 by filing a Joint Motion for the Scheduling of a Stipulation Hearing, an Uncontested Stipulated

Settlement executed by all parties, and supporting documentation. A scheduled contradictory hearing will not be converted to a Stipulation Hearing until the parties comply with Rule 6.
