**A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO JEREMY SCOTT, LLC whose office or place of business is at HARRISONBURG, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF WASTE OVER IRREGULAR ROUTES.**

Transportation of oil based mud, cuttings, and oilfield waste over irregular routes statewide restrictively amended with the restrictions reading as follows:

1. Restricted to transportation in five (5) 80 bbl bobtails only in the Parishes of Caddo, Bossier, Webster, Union, Claiborne, Bienville, Red River, DeSoto, Natchitoches, Winn, Grant, LaSalle, Catahoula and Concordia.
2. Restricted against the use of 130 bbl, 140 bbl and 150 bbl vac trucks;
3. Restricted against the use of owner-operators or leased trucks and trailers;
4. Applicant agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the date of issuance of the common carrier certificate to the Applicant in the proceeding.

(Reissued pursuant to S-32257 for a name change from Fuqua Oil Services, LLC originally issued pursuant to Order No. T-30797, dated April 08, 2010. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **JEREMY SCOTT, LLC** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
