After review of the record, the Louisiana Public Service Commission Staff ("Staff") states that the following actions have occurred in the above-referenced docket:


- (1) The application submitted by Telco Experts, LLC ("Telco Experts" or "Company") regarding a transaction to transfer direct control of Telco Experts to Redwood Services Group, LLC was filed on October 1, 2020.

- (3) The intervention period in this docket expired on November 2, 2020.
