AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES

A CERTIFICATE IS HEREBY GRANTED TO SKY-LIN SERVICES, LLC whose office or place of business is at KEITHVILLE, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Transportation of non-hazardous oilfield waste, statewide, with the following restrictions:

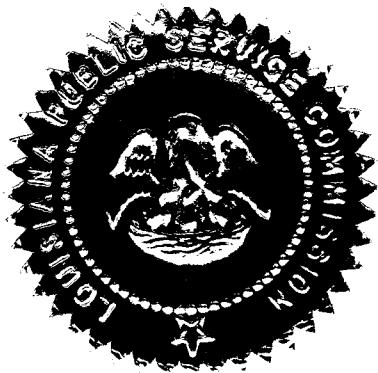
1. Restricted to transportation in twelve (12) vehicles, including but not limited to any combination of vacuum trucks/trailers, end dumps/dump trucks, and roll-on/roll-off trailers.
2. Restricted to the transportation of waste which originates north of a line drawn east and west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles, and West Feliciana Parishes.
3. Sky-Lin Services, LLC shall use no leased or owner operator trucks under this Certificate.
4. Sky-Lin Services, LLC agrees that no application for additional or expanded authority to transport non-hazardous oilfield waste shall be filed for a period of two (2) years from the date of this Certificate.

(Issued pursuant to Order No. T-34106 dated March 20, 2017 and L.R.S. 45:164 and the rules and regulations of the Louisiana Public Service Commission. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C).

Said SKY-LIN SERVICES, LLC shall perform such operations under prescribed rates or tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
