Dear Counsel:

This letter is to advise that the Louisiana Public Service Commission ("LPSC" or "Commission") Staff deems the request in this matter approved. The following actions have occurred in this matter:

1. Correspondence styled as the "Transfer of Control of Magna5 LLC" ("Request") was filed with the Commission on September 10, 2021;
2. The request concerns a transfer of control of Magna5 LLC from Magna5 Holdings, LLC to International Telcom, LLC;
3. Notice of the Request was published in the Commission's Official Bulletin dated September 17, 2021;
4. The intervention period expired without intervention or protest on October 4, 2021; and
5. Staff did not detect any compliance issues involving the Company.

This letter is to acknowledge that Staff has reviewed the above-docketed matter. Staff notes that this letter also provided, for the first time, notice of the name change of International Telcom, Ltd. to International Telcom, LLC ("ITL"). Section 301.M.2 of the Louisiana Public Service Commission's Regulations for Competition in the Local Telecommunications Market (Attachment A to General Order No. R-31839 dated March 11, 2014) ("Rules") requires notice of name change within 10 days. To rectify the failure of ITL to notify the Commission of the name change, Staff addressed it in this matter by including it in the *in re*: for this proceeding. Adherence to the Rules for any future name changes, etc. is required.

Considering all of the foregoing, the Request is deemed approved without further action by the Commission and the matter will be closed.

This approval is done without prejudice to the authority of this Commission to make an investigation or require any changes it may legally find to be appropriate and reasonably necessary.
