SPECIAL ORDER NO. 68-2024 - 8/30/2024 - 2024 Transportation Special Orders. Culbreath Corporation dba Culbreath Transportation, ex parte. In re: Request for cancellation of LPSC RI NO. 1550. THEREFORE, IT IS ORDERED LPSC RI NO. 1550 hereby is, cancelled.

GENERAL ORDER NO. 09-06-2024 (R-35595) - 9/6/2024 - Louisiana Public Service Commission, ex parte. In re: Review of the Schedule of Prescribed Rates and Requirements for Towing and Recovery services in General Order dated August 05, 2016. General Order dated 09-06-2024 (R-35595) authorizes a 15% increase on non-consensual towing and recovery rates. This General Order amends Attachment A to General Order dated 02-17-2022 (R-35595).

GENERAL ORDER NO. 09-10-2024 (R-36131) - 9/10/2024 - Louisiana Public Service Commission, ex parte. In re: Determination of Commission Jurisdiction Over the Various Methods of Providing Electricity to Electric Vehicles, and the Infrastructure Associated Therewith. General Order 09-10-2024 (R-36131) accepts the Staff Phase II Recommendation issued on July 26, 2024, which provides the regulatory requirements for ancillary issues arising from the interaction of regulated electric utilities and electric vehicle charging stations or electric vehicle charging equipment. The vote occurred at the Commission's August 14, 2024 Business and Executive Session.

GENERAL ORDER NO. 09-10-2024 (R-36199) - 9/10/2024 - Louisiana Public Service Commission, ex parte In re: Review and Possible Modification of the Commission's General Order dated October 10, 2013 Governing Transmission Certification and General Siting. This order establishes rules regarding the Commission's jurisdiction and authority over transmission certification and siting, and supersedes General Order dated October 10, 2013.

ORDER NO. S-37079 - 9/10/2024 - Delta States Utilities LA, LLC and Entergy Louisiana, LLC. In re: Joint application for approval of acquisition of Entergy's gas local distribution company assets to Delta States, and Delta States' request for authority to operate as a gas local distribution company and incur indebtedness related thereto. Order No. S-37079 accepts the Staff Report and Recommendation filed into the record on July 30, 2024, which accepts Delta States Louisiana and Entergy Louisiana's Joint Application subject to conditions within. This matter was considered at the August 14, 2024 Business and Executive Session.

ORDER NO. S-37186 - 9/6/2024 - Cebridge Telecom LA, LLC, ex parte. In re: Request to relinquish Eligible Telecommunications Carrier (ETC) Designation. Order No. S-37186 accepts the Staff Report and Recommendation filed into the record on July 16, 2024, which permits Cebridge Telecom LA to relinquish its statewide ETC designation. This matter was considered at the August 14, 2024 Business and Executive Session.

ORDER NO. U-36507 - 9/3/2024 - Verdant Microgrid, LLC and Ingevity Corporation, ex parte. In re: Petition for declaration of non-jurisdictional status. Order No. U-36507 dismisses this matter with prejudice.

ORDER NO. U-36669 - 9/10/2024 - Southern Spirit Transmission LLC, ex parte. In re: Request for certification, or in the alternative exemption, of the Southern Spirit Transmission Project pursuant to the Commission's General Order dated October 10, 2013 (The Transmission Siting Order). Order U-36669 accepts the Administrative Law Judge's Recommendation filed on June 5, 2024, except as to the cost-benefit analysis, with an additional condition that no design or construction costs associated with the transmission line be borne by ratepayers in the State of Louisiana. This matter was considered at the August 14, 2024 Business and Executive Session.

ORDER NO. U-37071 - 9/6/2024 - Entergy Louisiana, LLC, ex parte. In re: Application for approval of the Mondu Solar Power Purchase Agreement, expansion of the Geaux Green Tariff, and cost recovery. Order U-37071 accepts the Uncontested Stipulated Settlement filed into the records on July 1, 2024, which finds that ELL conducted a competitive solicitation for renewable generating resources, the Mondu Solar PPA is in the public interest, is deemed eligible for inclusion in the Geaux Green Option Rider, and other agreed to conditions. This matter was considered at the August 14, 2024 Business and Executive Session.

ORDER NO. U-37129 - 9/6/2024 - The Baton Rouge Water Works Company, d/b/a Baton Rouge Water Company, ex parte. In re: 2023 Formula Rate Plan Annual Report. Order No. U-37129 accepts the Joint Report and issues the Draft Order filed into the record on July 25, 2024, thereby authorizing BRWC to implement an increase in rates of approximately \$1,930,334.45, subject to conditions. The vote occurred at the Commission's August 14, 2024 Business and Executive Session.
