- 8 ADMINISTRATIVE LAW JUDGE MELISSA FREY: The next matter on the
- 9 docket this morning is Docket Number T-37099 Louisiana Public Service
- 10 Commission versus Tyrone's Detailing, Wrecker Service and Auto Repair, LLC.
- 11 In re: Cancellation of Common Carrier Certificate Numbers, is what the in re says,
- 12 6925-A for failure to maintain the required insurance coverage on file with the
- 13 Commission pursuant to the Commission's General Order dated October 13, 2023.
- Would the parties present please make their appearances for the record?
- 15 **MR. PAUL RACHAL:** Paul Rachal on behalf of Commission Staff.
- 16 **JUDGE FREY:** Let the record reflect that there is no one present in the courtroom
- 17 this morning on behalf of Tyrone's Detailing, Wrecker Service and Auto Repair,
- 18 LLC. Does the Staff plan to move forward this morning?
- 19 **MR. RACHAL:** Yes, Your Honor.
- 20 **JUDGE FREY:** All right. You can proceed, Mr. Rachal.
- 21 **MR. RACHAL:** Your Honor, Commission Staff is prepared to prove through both
- documentary and testimonial evidence that the carrier cited in this docket, Tyrone's
- 23 Detailing, Wrecker Service and Auto Repair, LLC, violated the Commission rules

- and regulations by failing to maintain the required insurance coverage on file with
- 2 the Commission as required by the Commission's General Order dated October 13,
- 3 2023. Your Honor, as a result of that violation, at the conclusion of this hearing,
- 4 the Commission is going to request that the carrier be found guilty for the
- 5 cancellation of carrier Common Carrier Certificate Numbers 6925-A. Your Honor,
- 6 at this time we'd like to call our first witness, Enforcement Agent Paul Amy.
- 7 Paul Amy after having been previously duly sworn, testified as follows:
- 8 <u>DIRECT EXAMINATION BY PAUL RACHAL</u>
- 9 MR. RACHAL: Can you please state your name and business address for the
- 10 record?
- 11 MR. PAUL AMY: My name is Paul Amy and my business address is Galvez
- Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana 70802.
- 13 **MR. RACHAL:** And where are you employed?
- 14 MR. AMY: I'm employed in the Transportation Division of the LPSC as an
- 15 Enforcement Agent.
- 16 MR. RACHAL: And could you describe some of your job duties as an
- 17 Enforcement Agent?
- 18 **MR. AMY:** I oversee insurance compliance for regulated motor carriers.
- 19 **MR. RACHAL:** And what documents are submitted to evidence insurance?
- 20 **MR. AMY:** A Form E is filed to show proof of bodily injury and property damage
- 21 liability insurance.
- 22 MR. RACHAL: And what Commission order requires carriers file forms as proof
- 23 of insurance?

- 1 MR. AMY: The Commission's General Order dated October 13, 2023 provides
- 2 requirements for insurance filings for motor carriers in Louisiana.
- 3 MR. RACHAL: And how is the Commission notified of the cancellation or
- 4 expiration of a carrier's insurance?
- 5 **MR. AMY:** We receive a Form K, a uniform notice of cancellation from the motor
- 6 carrier's insurance underwriter.
- 7 **MR. RACHAL:** And as part of your job duties that you just discussed, are you the
- 8 person who receives any correspondence or filings associated with a regulated
- 9 carrier's insurance?
- 10 **MR. AMY:** Yes.
- 11 MR. RACHAL: And are you familiar with the carrier cited in this docket,
- 12 Tyrone's Detailing, Wrecker Service and Auto Repair, LLC?
- 13 **MR. AMY:** Yes.
- 14 MR. RACHAL: And is this carrier a regulated motor carrier operating under
- 15 Common Carrier Certificate Number 6925-A?
- 16 **MR. AMY:** Yes.
- 17 **MR. RACHAL:** And what type of carrier is the carrier cited in this case?
- 18 **MR. AMY:** It's a towing and recovery motor carrier.
- 19 MR. RACHAL: And what is the carrier's mailing address on file with the
- 20 Commission?
- 21 **MR. AMY:** It's 191 West 5th Street, Laplace, Louisiana 70068.

- 1 MR. RACHAL: And has the Commission's Transportation Division received any
- 2 correspondence associated with this carrier's commercial automobile insurance
- 3 policy?
- 4 **MR. AMY:** Yes, we received a Form K.
- 5 **MR. RACHAL:** You have in front of you a document marked as Staff Exhibit 1.
- 6 Can you identify this document?
- 7 **MR. AMY:** Yes, it is a Form K for this particular carrier.
- 8 **MR. RACHAL:** And to whom was this document sent?
- 9 **MR. AMY:** To the Transportation Division.
- 10 MR. RACHAL: And who sent this document to the Transportation Division of
- 11 the Commission?
- 12 **MR. AMY:** AmGUARD Insurance Company, the carrier's insurer.
- 13 **MR. RACHAL:** And what date did the Commission receive this document?
- 14 MR. AMY: October --
- 15 **MR. RACHAL:** I think it's on the top of the document, perhaps.
- 16 **MR. AMY:** October 17, 2023.
- 17 **MR. RACHAL:** And do you know what the acronyms BI and PD at the top-right
- of the document mean?
- 19 **MR. AMY:** Bodily injury and property damage.
- 20 **MR. RACHAL:** And what does this document indicate?
- 21 MR. AMY: It indicates that Tyrone's Detailing, Wrecker Service and Auto Repair,
- 22 LLC bodily injury and property damage auto liability policy would be cancelled.

- 1 MR. RACHAL: And what is the insurance policy cancellation date provided in
- 2 that document?
- 3 **MR. AMY:** November 16, 2023.
- 4 **MR. RACHAL:** And what is the carrier's address on that document?
- 5 **MR. AMY:** 191 West 5th Street, Laplace, Louisiana 70068.
- 6 **MR. RACHAL:** And is this document signed by a company representative?
- 7 **MR. AMY:** Yes.
- 8 MR. RACHAL: Your Honor, Staff moves to offer, file, introduce into evidence
- 9 Exhibit 1, the carrier's commercial automobile insurance policy, a Form K.
- 10 **JUDGE FREY:** Staff Exhibit 1 is admitted.
- 11 **MR. RACHAL:** Thank you. And what did the Transportation Division do after
- receiving these documents?
- 13 **MR. AMY:** A notice of cancellation letter was mailed to the carrier.
- 14 MR. RACHAL: You have a document before you marked as Staff Exhibit 2.
- 15 Could you identify this document?
- 16 **MR. AMY:** This is a notice of cancellation letter.
- 17 **MR. RACHAL:** And to whom was this document sent?
- 18 **MR. AMY:** It's November 17, 2023.
- 19 **MR. RACHAL:** Who was it sent to?
- 20 **MR. AMY:** Tyrone's Detailing, Wrecker Service and Auto Repair, LLC.
- 21 **MR. RACHAL:** And what date did the Commission send this document?
- 22 **MR. AMY:** November 17, 2023.
- 23 **MR. RACHAL:** And what does this document indicate?

- 1 **MR. AMY:** It notifies Tyrone's, LLC that the Commission has received a Form K
- 2 from the underwriting company.
- 3 MR. RACHAL: And does the document indicate that a replacement should be
- 4 filed effective on the same day as the cancellation date of the previous coverage?
- 5 **MR. AMY:** Yes.
- 6 MR. RACHAL: And does the document state that the carrier should cease
- 7 operations until replacement coverage is filed?
- 8 **MR. AMY:** Yes.
- 9 MR. RACHAL: And is the carrier address on the document sent the same as the
- address on file for this particular carrier?
- 11 **MR. AMY:** Yes.
- 12 MR. RACHAL: Had Staff received a change of address notice from this carrier
- prior to this letter?
- 14 **MR. AMY:** No.
- 15 **MR. RACHAL:** Did you prepare this notice of cancellation letter for mailing and
- mail it the carrier by means of United States mail?
- 17 **MR. AMY:** Yes.
- 18 **MR. RACHAL:** And whose signature is on the notice of cancellation letter?
- 19 **MR. AMY:** That's Tammy Burl, LPSC Transportation Administrator.
- 20 MR. RACHAL: And is this signature automatically generated by the
- 21 Commission's database?
- 22 **MR. AMY:** Yes.

- 1 MR. RACHAL: Your Honor, Staff moves to offer, file, introduce into evidence
- 2 Staff Exhibit 2, the notice of cancellation letter for Tyrone's, LLC commercial
- 3 automobile insurance policy.
- 4 **JUDGE FREY:** Applicant -- I mean, Staff Exhibit 2 is admitted.
- 5 **MR. RACHAL:** Mr. Amy, can you confirm that was sent by regular mail?
- 6 **MR. AMY:** Yes.
- 7 **MR. RACHAL:** Was the letter returned by U.S. mail?
- 8 **MR. AMY:** No.
- 9 MR. RACHAL: After the notice of cancellation was sent, did the carrier submit a
- 10 Form E for proof of insurance?
- 11 **MR. AMY:** No.
- 12 **MR. RACHAL:** You have a document before you marked as Staff Exhibit 3, in
- 13 globo. Can you identify this document?
- 14 **MR. AMY:** Yes, this is the tentative hearing letter sent to Tyrone's, LLC.
- 15 **MR. RACHAL:** And to whom was the document sent?
- 16 **MR. AMY:** Tyrone's Detailing, Wrecker Service and Auto Repair, LLC.
- 17 **MR. RACHAL:** And what does this document indicate?
- 18 **MR. AMY:** It notifies Tyrone's, LLC that a tentative hearing date of January 11,
- 19 2024 was set for failure to maintain insurance on file with the Commission and that
- a citation will be issued if they do not submit proof by January 22, 2024.
- 21 **MR. RACHAL:** And what date did the Commission send this document?
- 22 **MR. AMY:** January 5, 2024.
- 23 **MR. RACHAL:** And was this sent by regular mail?

- 1 **MR. AMY:** Yes.
- 2 MR. RACHAL: And is the carrier address on the document sent the same as the
- address on file for this particular carrier?
- 4 **MR. AMY:** Yes.
- 5 MR. RACHAL: Has Staff received a change of address notice from the carrier
- 6 prior to sending out this letter?
- 7 **MR. AMY:** No.
- 8 MR. RACHAL: And did you prepare this letter for mailing and mail it to the
- 9 carrier by means of United States mail?
- 10 **MR. AMY:** Yes.
- 11 **MR. RACHAL:** And whose signature is on the tentative hearing letter?
- 12 **MR. AMY:** That's my signature.
- 13 **MR. RACHAL:** And were there any documents attached to this letter?
- 14 **MR. AMY:** Yes. The notice of cancellation letter dated November 17, 2023.
- 15 MR. RACHAL: Your Honor, Staff moves to offer, file, and introduce into
- evidence as Staff Exhibit 3, in globo, the tentative hearing letter sent to the carrier
- in this docket.
- 18 **JUDGE FREY:** Staff Exhibit 3, in globo, is admitted.
- 19 MR. RACHAL: Thank you. Did the U.S. Postal Service return the tentative
- 20 hearing letter admitted into evidence as Staff Exhibit 3, in globo, as undeliverable
- 21 for any reason?
- 22 **MR. AMY:** No.

- 1 MR. RACHAL: After the tentative hearing letter was sent to the carrier, did the
- 2 carrier submit a Form E indicating required insurance coverage?
- 3 **MR. AMY:** No.
- 4 MR. RACHAL: After receiving no response from the carrier, what action did the
- 5 Transportation Division take next?
- 6 **MR. AMY:** A citation was issued to Tyrone's, LLC.
- 7 MR. RACHAL: You have a document before you marked as Staff Exhibit 4, in
- 8 globo. Could you identify this document?
- 9 **MR. AMY:** This is the citation.
- 10 **MR. RACHAL:** And to whom was that document sent?
- 11 MR. AMY: That was sent to Tyrone's Detailing, Wrecker Service and Auto
- 12 Repair, LLC.
- 13 **MR. RACHAL:** And what date did the Commission send this document?
- 14 **MR. AMY:** January 31, 2024.
- 15 MR. RACHAL: And is the carrier address on the document sent the same as
- address on file for this particular carrier?
- 17 **MR. AMY:** Yes.
- 18 **MR. RACHAL:** And is this carrier address on the -- I'm sorry. Had Staff received
- a change of address notice from this carrier prior to the citation?
- 20 **MR. AMY:** No.
- 21 **MR. RACHAL:** And on the in re in the citation, is that a typo with common carrier
- certificate numbers? Is it supposed to be a number or numbers? Where it says
- 23 cancellation of Common Carrier Certificate Numbers 6925-A.

- 1 **MR. AMY:** Oh, okay. That should be number and not plural.
- 2 **MR. RACHAL:** Okay. Just wanted to confirm that.
- 3 **MR. AMY:** Right.
- 4 **MR. RACHAL:** Did you prepare the citation -- I'm sorry. Whose signature is on
- 5 the citation, again?
- 6 **MR. AMY:** That's Tammy Burl, LPSC Transportation Administrator.
- 7 MR. RACHAL: And you are not testifying to the validity of the signature, just
- 8 that this document was prepared by you for her signature?
- 9 **MR. AMY:** Yes.
- 10 **MR. RACHAL:** Were there any documents attached to this letter?
- 11 **MR. AMY:** Yes. The tentative hearing letter and the notice of cancellation.
- 12 **MR. RACHAL:** Did the citation provide the carrier notice that a citation fee in
- the amount of \$25 had been assessed to the carrier's account?
- 14 **MR. AMY:** Yes.
- 15 **MR. RACHAL:** And did the citation also provide the carrier notice that an order
- may be issued by the Commission, cancelling the carrier common carrier number
- 17 for failure to maintain the required insurance coverage?
- 18 **MR. AMY:** Yes.
- 19 MR. RACHAL: What was the hearing date, time, and location provided in the
- 20 citation?
- 21 **MR. AMY:** Tuesday, April 9, 2024 at 9:30 AM, Galvez Building, 11th Floor, 602
- North 5th Street, Baton Rouge, Louisiana 70802.

- 1 MR. RACHAL: Was notice of the citation published and available to the general
- 2 public in the Commission's Official Bulletin Number 1316, dated February 2,
- 3 2024?
- 4 **MR. AMY:** Yes.
- 5 MR. RACHAL: Your Honor, Staff moves to offer, file, and introduce into
- 6 evidence the citation with its attachments as Staff Exhibit 4, in globo.
- 7 **JUDGE FREY:** Staff Exhibit 4, in globo, is admitted.
- 8 MR. RACHAL: Thank you. Once Ms. Burl executed the citation, introduced as
- 9 Staff Exhibit 4, in globo, did you mail a citation to the carrier?
- 10 **MR. AMY:** Yes.
- 11 MR. RACHAL: Was the citation sent by certified mail with a return receipt
- request as well as regular mail?
- 13 **MR. AMY:** Yes.
- 14 **MR. RACHAL:** Was the regular mail returned for any reason?
- 15 **MR. AMY:** No.
- 16 MR. RACHAL: Was the citation mailed certified delivered to the best of your
- 17 knowledge?
- 18 **MR. AMY:** Yes.
- 19 **MR. RACHAL:** You have in front of you a document marked as Staff Exhibit 5.
- 20 Do you recognize this document?
- 21 **MR. AMY:** Yes, that's a copy of the certified mailing envelope with the contained
- 22 citation sent to the carrier.

- 1 MR. RACHAL: Your Honor, you have the original envelope before you for
- 2 inspection. Does the tracking number on the envelope, ending in 5339, match that
- 3 on the citation?
- 4 **MR. AMY:** Yes.
- 5 **MR. RACHAL:** And what does this document indicate?
- 6 MR. AMY: It indicates that the citation sent certified mail was returned as
- 7 unclaimed.
- 8 MR. RACHAL: Is the address on this unclaimed envelope the same address that
- 9 is on file with the Commission?
- 10 **MR. AMY:** Yes.
- 11 **MR. RACHAL:** And the notation on the front of the envelope, did you put that
- 12 there?
- 13 **MR. AMY:** No, that appears to be a notation made by the postal service.
- 14 **MR. RACHAL:** And on the back or front of the envelope, does it indicate when
- 15 Staff received the envelope back?
- 16 MR. AMY: Yes. Staff received it back on March 20, 2024.
- 17 **MR. RACHAL:** Did you write that or was that put there, the date?
- 18 **MR. AMY:** Oh, the March on the stamp, yes, I wrote over it for March.
- 19 MR. RACHAL: Your Honor, Staff moves to offer, file, introduce into evidence
- 20 Exhibit 5.
- 21 **JUDGE FREY:** Staff Exhibit 5, copies of the front and back of the envelope with
- certified mail receipt ending in 5339, is admitted. And I do have the original

- 1 envelope in front of me and it matches the copies offered as Staff Exhibit 5. So
- 2 Staff Exhibit 5 is admitted.
- 3 MR. RACHAL: Thank you. As of today, has a representative of the carrier filed
- 4 the appropriate documents to close its certificate?
- 5 **MR. AMY:** No.
- 6 **MR. RACHAL:** As of today, has the carrier filed proof of insurance or a Form E
- 7 with the Commission?
- 8 **MR. AMY:** No.
- 9 MR. RACHAL: Is Staff seeking that the carrier be found guilty of failing to
- maintain insurance filings and that Common Carrier Certificate Number 6925-A be
- 11 cancelled?
- 12 **MR. AMY:** Yes.
- 13 **MR. RACHAL:** And does Staff also seek that the carrier pays a \$25 citation fee
- as authorized by the June 7, 2006 General Order?
- 15 **MR. AMY:** Yes.
- 16 **MR. RACHAL:** That's all the questions I have, Your Honor.
- 17 **JUDGE FREY:** Thank you. I have a few clarifying questions.
- 18 **MR. AMY:** Okay.
- 19 **JUDGE FREY:** Do you have what was admitted as Staff Exhibit 3, in globo, in
- 20 front of you, Mr. Amy?
- 21 **MR. AMY:** Yes.
- 22 **JUDGE FREY:** Was this document sent to the carrier via email?
- 23 **MR. AMY:** It appears that it said also via email on the -- yeah -- on the document.

- 1 **JUDGE FREY:** Okay. But before the hearing today, did you confirm that it was
- 2 sent via email?
- 3 **MR. AMY:** I did not.
- 4 **JUDGE FREY:** But it indicates on the letter, also sent via email?
- 5 **MR. AMY:** Right.
- 6 **JUDGE FREY:** Thank you. Do you have what was admitted as Staff Exhibit 5 in
- 7 front of you?
- 8 **MR. AMY:** Yes.
- 9 **JUDGE FREY:** And it consists of two pages. On the first page, Mr. Rachal asked
- 10 you about a notation, and I believe your testimony was that it appeared to be put
- there by the postal service. Could you just verbally explain for the record what
- 12 notation you were referring to?
- 13 **MR. AMY:** The notation is right above the Exhibit 5, to the left, above that.
- 14 **JUDGE FREY:** Thank you. And you said that it was unclaimed. What indicates
- that the certified mail was unclaimed?
- 16 MR. AMY: Well, there's a sticker from the Postal Service that says return to
- 17 sender, unclaimed.
- 18 **JUDGE FREY:** And does it indicate anything else?
- 19 **MR. AMY:** Unable to forward.
- 20 **JUDGE FREY:** Thank you. I have no further questions. Do you have any follow
- 21 up for Mr. Amy?
- 22 **MR. RACHAL:** No more questions for him.

1	JUDGE FREY: Thank you. If you are going to be the witness in the next hearing		
2	you can remain seated, Mr. Amy. Mr. Rachal.		
3	MR. RACHAL: Your Honor, as a result of this violation, we are asking the		
4	Commission requests that the carrier be found guilty and cancel the Common		
5	Carrier Certificate Number 6925-A and also enforce the \$25 citation fee.		
6	JUDGE FREY: Thank you. If there is nothing further, that matter will be		
7	adjourned.
