RULING

ON UNOPPOSED JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

On May 31, 2019, Cleco Power, LLC ("Cleco Power"), Packaging Corporation of America ("PCA"), and Louisiana Public Service Commission ("Commission") Staff filed an Unopposed Joint Motion to Amend Procedural Schedule ("Joint Motion"), requesting amendment of the procedural schedule that was established at the April 30, 2019 status conference.

June 3, 2019	Deadline for Cleco Power to file a motion addressing the scope of the docket.
June 28, 2019	Deadline for Commission Staff and PCA to file a response to Cleco Power's June 3, 2019 motion. Commission Staff and PCA's responses shall not be limited by Cleco Power's June 3, 2019 filing, but may address issues of scope to respond to Cleco Power's January 31, 2019 and June 3, 2019 filings.
June 28, 2019	If the parties have not reached an agreement on scope or otherwise prior to this date, then the parties are directed to submit a filing informing the Tribunal as such. Any such filing shall further propose a date for convening of a new status conference to revisit the mocedural schedule.

PLEASE TAKE FURTHER NOTICE that all other deadline dates, including the January 28-30, 2020 hearing dates, are suspended at this time. A hearing date will be scheduled upon the request of the parties.

PLEASE NOTE: Should the parties wish to proceed by stipulation, compliance with Rule 6 of the Commission's Rules of Practice and Procedure is required. Accordingly, an uncontested stipulation hearing will not be scheduled or convened until the parties have complied with Rule 6 by filing a Joint Motion for the Scheduling of a Stipulation Hearing, an Uncontested Stipulated Settlement executed by all parties, and supporting documentation. A scheduled contradictory hearing will not be converted to a Stipulation Hearing until the parties comply with Rule 6.
