DBA PCM LOGISTICS</u> whose office or place of business is at <u>SCOTT, LOUISIANA</u> authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Jel Oil or any other liquid mud, chemical or acid, in bulk, in tank trucks, used in the drilling, bringing in or cleaning out of oil wells, including waste generated at an oil well site through the drilling, bringing in or cleaning out thereof.

And, in addition, salt water and fresh water from, to and between all points, over irregular routes within the State of Louisiana. (To be removed when certificate is issued due to de-regulation of the two commodities).

Additionally, transportation of those commodities listed in certificate by dump truck; i.e., transportation of commodities in dump trucks from oil well sites, over irregular routes.

Restricted against the transportation of oilfield waste in dump trucks in the following Parishes: St. John the Baptist, St. James and St. Charles.

Restricted in that no amendment shall be made to this authority for a period of ten years from the date of issuance, March 3, 1998.
