ORDER NO. R-36131 - 11/12/2024 - Louisiana Public Service Commission, ex parte. In re: Determination of Commission Jurisdiction Over the Various Methods of Providing Electricity to Electric Vehicles, and the Infrastructure

Associated Therewith. Order No. R-36131 grants ELL, Cleco Power, and SWEPCO's Joint Motion, thereby remanding and reopening the rulemaking to review and possibly clarify Sections 601 and 801 of General Order R-36131 (CORRECTED). ORDER NO. U-37209 - 11/8/2024 - South Coast Gas Company, Inc., ex parte. In re: Request for an interim Operating Revenue Rider. U-37209 accepts the Uncontested Stipulated Settlement filed into the record on September 27, 2024, which recommended that the Commission should authorize South Coast Gas to implement a rate rider of approximately \$2.55 per month for a period of 12 months in order to recover approximately \$568,322.75 in revenues that would be directly applied to short term debt accounts as allocated by a percentage total subject to additional reporting conditions. This matter was considered at the October 16, 2024 Business and Executive Session.

ORDER NO. U-37210 - 11/12/2024 - South Louisiana Electric Cooperative Association, ex parte. In re: Formula Rate Plan Annual Report 2023 Test Year Filing. Order No. U-37210 accepts the Joint Report and issues the Draft Order filed into the record on October 4, 2024, which authorizes SLECA to implement a \$9,184,515 rate increase pursuant to its Formula Rate Plan for the 2023 Test Year. The vote occurred at the Commission's October 16, 2024 Business and Executive Session.

ORDER NO. U-37215 - 11/8/2024 - Utilities, Inc. of Louisiana, ex parte. In re: Formula Rate Plan Annual Report for Test Year 2023. Order U-37215 accepts the Joint Report for the 2023 Test Year Rate Stabilization Plan filing submitted on September 24, 2024, which states that an increase in rates of \$955,154, allocated as \$66,734 to water and \$888,420 to wastewater is necessary and in accordance with the terms of Utilities, Inc. of Louisiana's Formula Rate Plan. This matter was considered at the October 16, 2024 Business and Executive Session.
